BPG BUILDING GUIDELINES CHECKLIST

In order to provide a safe and enjoyable atmosphere, we ask that our patients follow these guidelines:

- ! You must be at least 18 years old and have state-issued ID and an accepted medical cannabis card or recommendation with you to enter.
- ! You must show these items to the receptionist and the safety team each time you visit.
- ! Please turn off cell phones. No cameras or recording devices may be used in the building.
- ! Lounge visits are limited to 2 hours per day.
- ! Treat everyone in the building and our neighbors with respect.
- ! Absolutely no alcohol, hard drugs, or weapons of any kind are allowed on the premises.
- ! Please control your pets at all times and clean up after them.
- ! In case of an emergency, stay calm and follow instructions from BPG staff.

GOOD NEIGHBOR POLICY CHECKLIST

We have worked hard over the past 9 years to build positive relationships with the homes and businesses in our neighborhood. Please help us by always following these rules:

- ! Always drive carefully and courteously. Turn car stereos down.
- ! Use only our lot or public parking – Never park your car in a neighbor's lot or in the bus stop.
- ! Do not linger in your car or on the sidewalk after you visit BPG; you are welcome to stay and socialize in our lounge if you do not have guests waiting outside.
- ! Keep all medicine out of sight when you exit and as you drive away.
- ! You must never consume cannabis in the parking lot or neighborhood.
- ! You must never sell or distribute medicine you receive at BPG.
- ! There is absolutely no exchange of money between patients and guests outside the building.
- ! Overnight parking is NOT allowed.
- ! No children under 12 years old left unattended in the parking lot or in your vehicle.
